Best Practices regarding Substance Use Disorder (SUD) services includes assessment, treatment planning and interventions to address client needs.

SUD assessments assist in tailoring individual treatment and supportive services, can contribute to clinical diagnoses and the recommendations for intensity and setting of treatment needed.

An SUD assessment may also identify co-occurring mental disorders and areas of life functioning affected, such as family, employment, housing, or criminal history, possibly requiring a specific service or outside referral. Incorporation of ASAM and DSM-5-TR criteria can enhance evidence-based assessment and placement criteria, pairing risk with the appropriate level of care.

## As a result of this two-day training participants will be able to:

- Describe elements of and differentiate between screening and assessment.
- Identify recommended screening and assessment techniques and tools.
- Implement evidence-based best practices through the interface of the DSM-V-TR SUD diagnostic criteria and the Dimensions outlined by the American Society of Additive Medicine (ASAM).
